Terms & Conditions

1. Promoter

The promoter of this promotion is **Value Motors Limited** (“Value Motors”, “we”, “us”, “our”).

2. Promotion Period

This promotion is conducted on a **monthly basis**.

For each monthly draw:

The promotion opens at **12:01am on the first calendar day of the month**.

The promotion closes at **11:59pm on the last calendar day of the month**.

Each month constitutes a **separate and independent promotion period**.

3. Eligibility to Enter

Entry is open to individuals who, during the relevant monthly promotion period:

- Purchase a vehicle from Value Motors; and
- Are **18 years of age or older** at the time of purchase; and
- Are **permanent residents or citizens of New Zealand**; and
- Provide valid identification and proof of purchase if requested.

Proof of eligibility may include (but is not limited to):

- A valid New Zealand driver licence or passport; and
- A completed vehicle sale agreement issued by Value Motors.

Employees of Value Motors, its related entities, and their **immediate family members** are not eligible to enter.

4. How to Enter

Eligible purchasers will receive entries into the monthly prize draw based on the products purchased during the promotion period.

Entries are allocated as follows:

1 vehicle purchase

= **One (1) entry**

1 vehicle purchase + mechanical warranty

= **Two (2) entries**

1 vehicle purchase + mechanical warranty + paint protection

= **Three (3) entries**

Where multiple eligible products are purchased in the same transaction, the corresponding number of entries will be issued.

Each entry represents **one equal chance of winning** in the monthly draw.

Entries are **automatically generated at the time of purchase** once the vehicle sale agreement has been completed.

No additional payment, fee, or separate consideration is required to participate in the prize draw.

Entries are **not transferable** and cannot be exchanged for cash or credit.

This promotion is conducted **in-store only** and is not operated online.

5. Entry Records

All eligible entries will be recorded and maintained in a **secure electronic register maintained by Value Motors**.

Each eligible entry will be assigned a **unique reference number**.

Records will be retained for **audit and compliance purposes** in accordance with applicable law.

6. The Draw

One (1) winner will be drawn **wholly by chance** from all valid entries received during the relevant monthly promotion period.

Each valid entry will have **an equal chance of winning**.

The draw will take place on the **5th day of the following month or as selected by Value Motors.**

The draw will be conducted using either:

- A secure **random number generator**; or
- A **manual random draw method** overseen by a senior Value Motors representative.

The draw process **may be recorded on video** for transparency and record-keeping purposes.

7. Prize Details

The prize is **NZD \$5,000 cash**.

The prize is **not transferable, exchangeable, or redeemable** for goods or services.

The prize will be paid by **direct bank transfer** to the winner's nominated New Zealand bank account.

Payment will be made within **five (5) business days** of winner verification.

8. Winner Notification

The winner will be notified directly using the contact details provided at the time of vehicle purchase.

Reasonable efforts will be made to contact the winner.

If the winner cannot be contacted within **10 business days**, Value Motors reserves the right to **redraw the prize**.

9. Vehicle Sale Completion Requirement

Entries into the promotion are **only valid where the vehicle purchase transaction is fully completed.**

If a vehicle purchase is:

- Cancelled
- Refunded
- Rescinded
- Declined due to finance failure
- Or otherwise does not proceed to final settlement

then any associated entries into the promotion will be **deemed void and removed from the draw.**

Value Motors reserves the right to verify that the vehicle purchase has been **completed and settled** prior to awarding the prize.

10. Product Eligibility Adjustment

Where additional entries are granted based on the purchase of optional products (including but not limited to **mechanical warranties or paint protection packages**):

If those products are subsequently:

- Cancelled
- Refunded
- Removed from the vehicle sale agreement
- Or otherwise not completed as part of the final transaction

then the corresponding additional entries may be **removed or adjusted** prior to the prize draw.

11. Jurisdiction

This promotion is open to **New Zealand residents only**.

The promotion is governed by the **laws of New Zealand**.

Any disputes will be subject to the **exclusive jurisdiction of New Zealand courts**.

12. Fair Trading & Compliance

Entry is **incidental to the purchase of a vehicle and optional additional products** and does not require any additional fee for participation in the prize draw.
